AM RADIO FOR EVERY VEHICLE ACT

On January 29, The AM Radio for Every Vehicle Act was reintroduced in Congress. This law ensures that all vehicles include AM radio as a standard feature. This bipartisan bill will safeguard an essential part of our communications infrastructure and ensure that companies are prioritizing public safety. These critics claim that the department's focus on diversity, equity, and inclusion (DEI) is to blame for the failure to contain recent fires, arguing that these women are unqualified because they are "DEI hires." Legislation Lookout:

H.R. 28: PROTECTION OF WOMEN & GIRLS IN SPORTS ACT

The H.R. 28: Protection of Women and Girls in Sports Act would prohibit transgender women from participating in women or girls sports. The bill passed the House of Representatives on January 14, 2025. This bill would be detrimental to the transgender, nonbinary, and intersex individuals that are seeking to build community through sports. NHMC signed onto a **letter**, led by the The Leadership Conference on Civil and Human Rights, opposing this bill. This legislation will reach the Senate and be called to a vote. BIRTHRIGHT CITIZENSHIP: TRUMP'S EXECUTIVE ORDER

In Trump's first week as president, he signed a consequential executive order aiming to restrict birthright citizenship. This order suggests that if neither parent is of any legal permanent status when their child is born, that child born on U.S. soil may not be eligible for citizenship. This order directly challenges Supreme Court decisions on the 14th amendment that have been in place since 1868. Almost immediately, twenty-two states filed lawsuits in opposition. This legal battle is expected to reach the Supreme Court. NHMC will continue to monitor this issue and ensure that you have the most up to date news. For more information, click here.
